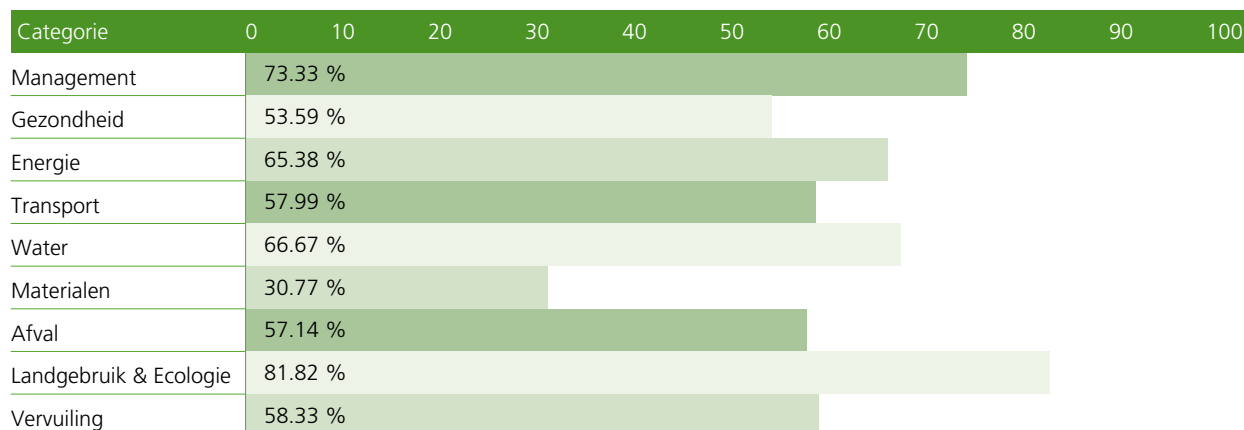

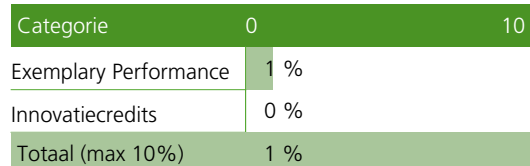


Sanoforum - fase 1 (zorggebouw)
